Gentlemen,

It is with pleasure and satisfaction the 23rd Annual Report and Financial Statement of the Club is submitted to you on behalf of the President and Committee.

The Committee takes this opportunity to express its appreciation for the whole-hearted co-operation received from members during the season.

Although the carnival results don't read as well as last season, it must be remembered that quite a few "Old Hands" retired from competitive work this season, and their places were taken by promoted juniors. The experience gained by these lads should stand them in good stead for the coming season.

All things considered, the past year has been very successful, although membership has decreased. Awards gained have increased considerably, readily showing that the high standard of efficiency set in previous years is being maintained.

One regret I express on behalf of the Committee is the unfortunate position the Club is in regarding junior membership. From last season's junior membership of 12 this season's figure was only two. The Committee's efforts to increase this total have failed to bear fruit. This matter will have to be given serious consideration by the incoming Committee.

#### AFFILIATIONS.

The Club is affiliated with the South Australian Branch of the Royal Life Saving Society and the South Australian Amateur Swimming Association.

Comparison of these figures readily show a big decrease on last season's record total. Although this decrease made it rather difficult for the Patrol Captain (G. Cleal) to keep Patrols fully rostered a glance at his report will show figures compared more than favourably with the total hours of last year.

The drop in junior membership has already been commented upon.

#### LIFE SAVING.

The Patrol Captain (G. Cleal) has supplied the following report:— Members again carried out rostered patrols during the past season. The hours patrolled for the year totalled 268½, showing an increase of 67½ hours over the previous season. This, considering the big drop in membership, was quite a good effort. M. Aitchison had 23½ hours' patrol to his credit.

Many schools sought patrols for their picnics, and these were willingly supplied, although it is difficult to arrange week day patrols, members on shift work overcame this difficulty.

Sixteen (16) rescues were effected during the season. In a number of these cases the Club's carbogen outfit had to be utilised.

We take the opportunity to extend our sincere thanks and appreciation to C.I.G. (S.A.) Ltd. for keeping the carbogen apparatus in order and filling the gas containers free of charge.

#### LIFE SAVING AWARDS.

The number of awards gained by Club members this season is something of which to be proud. The total awards of 83, as against 48 last season, represents an increase of 73%, which enabled the Club to obtain second place in the contest for the Royal Life Saving Society's Excellence Challenge Shield.

#### AN URGENT NEED.

The Committee has given many hours of thought to the matter of the need for additional safety measures required on our beach. It was unanimously decided that the most urgent need was for a suitable water craft in which to carry out patrols and rescues in very rough weather, long distances from the shore, and general patrol work.

The Club membership does not permit patrols being posted at bathing places right along the beach from West Beach to the other side of Grange. For the same season (distance) it is not possible to control bathing in specified areas, as is done in other States. We are compelled, therefore, to limit our patrols to two or three men on the jetty and two men along the beach 400 yards each side of the jetty, for each period. Three periods of 1½ hours Saturdays and Sundays are the usual practice; on holidays anything up to nine hourly periods from 9 a.m. to 6 p.m. are required, members often doing two or three duties.

On the basis of this the Committee decided a Standard Type Surf Boat (as used by Sydney clubs) was the ideal craft. With this constant watch could be kept during patrol hours from one end of our territory to the other. These craft are fitted with many devices to aid this particular type of work.

At the Committee's direction the Secretary put the matter before the local Council for assistance, and it is very gratifying that this body decided to assist in the purchase of a Surf Boat to the extent of £50; and also bear the cost of enlarging portion of our Club building to house same.

A first class secondhand boat of the type required was on hand at the time in Sydney, but before we could complete negotiations for its purchase it was sold. Further inquiries along this line have been made without result. Good condition secondhand craft are unavailable. From information just received it will take from 12 to 18 months to obtain delivery of a new boat costing on present day standards approximately £250 to land here.

Action must be taken now, and the Committee intend to launch an appeal, public if necessary, to raise funds to procure a Surf Boat, otherwise many lives are going to be lost in the next few years. Any assistance, financial, mainly, will be deeply appreciated, and interested parties are urged to contact the Club Secretary. It is not only for the safety of locals that this appeal is going to be made, but for the many thousands from surrounding districts that visit our beach.

#### LIFE SAVING KNOWLEDGE AND INSTRUCTION.

As declared in the objects of the Club, it is our desire to bring about a wider knowledge of the principles of life saving; what to do in an emergency, how to go about the job of restoring respiration, etc.

In this connection any person, youth club, or similar body, school or group desirous of instruction in this important work, are earnestly requested to contact the Club Secretary and ask for instructors. These will readily and very willingly be made available, classes arranged, and awards taken if desired.

GENERAL.

The Gear Stewards are to be complimented on the manner in which they have looked after and repaired where necessary the equipment of the Club. A valuable addition to this equipment was a much-needed powerful pair of binoculars. The Henley and Grange Council again assisted us in the purchase of same to the extent of £13/10/-, and the donation of our staunch supporter and worthy patron, A. W. Jolly, Esq., made up the balance.

The junior membership of only two, although already mentioned, is very serious. Last season we had 12 juniors, and in 1945-46 18. Juniors today are the backbone of the Club tomorrow, and every effort will have to be made to rectify this alarming position.

Unfortunately, Merv. Butterfield (Captain) and Ron Gubbins (Committee) found it necessary, through business reasons, to resign their positions during the year, Len Northey and Alan Roberts taking the respective positions. However, Merv. remained on the Committee and Alan took over the position of Chief Instructor from Len.

#### FINANCE.

Although the Club's bank balance stands at a healthy figure, it must be remembered this position is the result of social activities designed to enable the Club to build suitable premises for the work we carry out. With this in mind, it is regretable that during the year the bank balance was reduced by approximately £35.

The £5 and £1 Savings Certificates matured, and the cash realisation was deposited in the bank.

The reduction of  $\pounds 35$  in the bank balance shows that our income is insufficient to meet the needs of our work, and the incoming Committee will have to give this matter serious consideration. The donations from supporters help considerably, but assistance from areas served by our beach will have to be sought.

#### ANNUAL GENERAL MEETING.

The twenty-second Annual General Meeting was held in the Council Chambers, Henley Town Hall, on Friday, October 3rd, 1947. The President, Mr. R. J. McDonough, presided over the meeting, which was attended by 28 active members. The Secretary, A. H. J. Hallett, presented the Annual Report, and the Treasurer, G. W. King, the financial statement. These were duly adopted.

#### SPECIAL GENERAL MEETING.

A Special General Meeting was convened and held in the Club Shed on February 12th, 1948, to consider a motion of A. H. J. Hallett, namely, "That Clause 20 of the Club Constitution be amended to read, 'The Club blazer shall consist of plain royal blue material with three chromium buttons and with \{\frac{3}{2}} in. white binding on tops of pockets and on outside of sleeve cuffs 3 in. from bottom.'"

This motion was carried with a proviso that owing to the present inferior quality of binding, this shall not be used until sanctioned by the Committee. However, a good quality binding has now been approved.

The moving of the above motion resulted from the inability of manufacturers to supply the former cloth of § in, royal blue and white stripes.

#### MELBOURNE TRIP.

With the kind permission of the Australian Federal Council, the Victorian Branch Executive, and the S.A. Branch Executive, and the assistance of Mr. E. A. Pleydell, Federal and Victorian Secretary, a visit to Melbourne to take part in the Victorian Reel and Line Championship on March 6th was arranged.

The party of 25, under the management of Club Secretary C. Fielder and captaincy of D. Hemsley, left Adelaide on March 4th and was met on arrival in Melbourne by Mr. E. A. Pleydell and Messrs. Bill Quinn and Alan Forster, of the West St. Kilda Club.

The West St. Kilda Clubhouse and equipment were placed at our disposal for the purpose of training during our stay, a gesture we appreciated very much. This fine clubhouse made our lads very envious.

Prior to the carnival the whole party was entertained at lunch by the Victorian Executive at the St. Kilda Kiosk. The sight of approximately 30 teams, comprised of 20 personnel, competing in the March Past (compared with South Australia's seven or eight teams of eight men) made a striking contrast.

Although the Henley team was not placed in any of the main events the experience gained more than compensated for any disappointments. Interpretation of reel and line and resuscitation work differed somewhat from the S.A. view, and it is good to hear that moves are afoot to standardise this. This alone proves the worth of periodical interstate trips by teams from this State.

Following the carnival our party were guests of the St. Kilda Club at the Championship Ball. Sunday a friendly challenge carnival against our good friends West St. Kilda was held, and if I remember rightly we were successful in the tug-o'-war. A fine tea was provided by the West St. Kilda Club, and in the evening they entertained us in the clubhouse, star performers being Bill Quinn and Alan Forster.
