Gentlemen,

The President and Committee submit with pride and pleasure the 24th Annual Report and Financial Statement.

The Club's record during the last season has been an excellent one, and members can take satisfaction in the results. As forecast in last season's Report, the benefit of experience gained by promoted Juniors has been reflected in the success gained in Carnivals this season. One of these lads, Ray Parnell, was selected to represent the State in the Trenchard Miller Shield competition in Melbourne.

Membership showed an over-all decrease of two (2) on last season; but the main problem is the non-existence of Junior members.

The efficiency of members is still being maintained at the high standard set in previous seasons, as results will prove. Awards gained totalled 80, a decrease of three (3) on last season.

The Club is affiliated with the South Australian Branch of the Royal Life Saving Society and the South Australian Amateur Swimming Association.

As mentioned earlier, Junior Membership is our main problem, and it is rather serious that our Junior section did not function this season. However, we are hopeful of a much better position next season. Quite a few young lads contacted showed considerable interest.

Schools in districts served by our beach have been circularised and contacted personally, with encouraging prospects.

Ron Gubbins and Jim Vaux were admitted as Associate Members of the Club, the first for many years.

LIFE SAVING.

Patrol Captain (D. Hemsley) has supplied the following reports:

Rostered Patrols were carried out during the season with the utmost efficiency, and it is creditable to note that no swimming fatality occurred at our beach. There were several instances when, but for the alertness of Patrols, casualties would have undoubtedly occurred. A total of 18 persons were rescued or assisted from difficulties. On one occasion the Club's Carbogen Outfit had to be used on a girl for nearly half an hour before she was revived, once again stressing the value of this equipment.

A feature of the season's rescues was the number of capsized yachts calling for assistance, again stressing the need for the Patrol Rescue Boat, which the Club will have in commission next season. The yachts have a habit of capsizing a considerable distance from shore, usually in heavy weather, and the use of the boat will obviate the boatman's life being placed in danger from cross currents and a fouling line, in these cases.

The season's total hours patrolled were 188, a decrease of 80 hours on the previous season. However, in view of the abnormal summer, the figures are quite satisfactory. Largest individual total was Max Aitchison with 20 hours, a very creditable effort. Tom Jennings, with 16 hours, and Ray Parnell, 10½ hours, also gave excellent service.

A number of schools applied for, and were willingly given, Patrols for their week-day picnics.

In the Society's Season's Aggregate Competition the Club finished First in the Surf Rescue, winning 12.5 points; and Third in the March Past, finishing only .6 behind the winning Club.

MISS LIFE SAVING COMPETITION.

It is pleasing to record the success of Miss Henley (Peg Gregory) in winning this Competition, sponsored by the Royal Life Saving Society. A total of £2,172 was raised by the six clubs for the Society's Central Fund; this Club's share of the total was £518, a result which reflects considerable credit on the Organising Committee, headed by Carol Reynolds and Rhonda Middlebrook.

The purpose of the contest was to raise funds to enable the Royal Life Saving Society and clubs to undertake an Instructional Drive; this will begin next season.

PATROL RESCUE BOAT.

In the last Annual Report lengthy mention was made of the necessity for the Club to purchase a suitable Patrol Rescue Boat. The Committee is pleased to be in a position to state that the boat will be in commission at the beginning of next season. Sufficient funds for the purchase of a new boat, in the vicinity of £300, has been raised, and to all those who have given their assistance our grateful thanks are extended. The mention of all names would take up considerable space, but the opportunity of thanking the Henley and Grange Council for a grant of £50, plus the cost of extending the Junior Shed to house the boat, and also Club Patron A. W. Jolly, Esq., for a generous donation, cannot be overlooked.

In connection with the acquiring of this patrol boat, another phase of efficiency in the method of saving the lives of those in distress is being investigated, namely, the possibility of using three-way radio (Walkie-Talkie, or similar) in times of emergency between the Club Shed, Jetty Patrol and Boat Patrol.

FINANCIAL REPORT.

Hon. Treasurer G. W. King has supplied the following report:

"I have very much pleasure in presenting the Financial Report at the conclusion of a most successful season, both financially and competitively. The outstanding financial success has been due mainly to our hard working Secretary and the Miss Life Saving Committee. It is some years since our Club has had a bank balance of over £800 and, although £300 will be used in the purchase of the Surf Rescue Boat, I hope members will strive next year to make our balance rise to its first thousand on the way to provide for the building of a new Club House.

"Further to our Secretary's remarks, I wish to thank all persons who have financially assisted this Club, and hope that they will continue to support us in the future."

ANNUAL GENERAL MEETING.

The 23rd Annual General Meeting of the Club was held in the Council Chambers, Henley Town Hall, on Friday, October 1st, 1948. Vice-President N. Tucker, Esq., presided over the meeting, which was attended by 31 members. The Secretary, C. Fielder, presented the Annual Report and Treasurer G. King the Financial Statement. These were duly received and adopted.

State Executive Members of the Society, E. Meldrum, Esq. (Chairman), J. R. Hardy, Esq. (Hon. Secretary) and D. Collaton, Esq. (Chief Instructor) attended, and outlined proposed activities of the Society for the coming season.

The following amendments were made to the Club Constitution:

- (a) Clause 7 amended to read: "Subscription.—The Subscriptions shall be—Active Members, 5/- per annum; Active Reserve, 7/6 per annum; Junior Members, 2/6 per annum; Associates, £1/1/- per annum."
- (b) Clause 6a amended by deleting the words "400 yards test swim within 8 minutes" and inserting "400 metres within 8 minutes and 30 seconds," and deleting the words "The candidate must swim 400 yards in 8 minutes in the sea" and inserting "The candidate must swim 400 metres within 8 minutes and 30 seconds in the Henley Baths."
- (c) Clause 4a amended by deleting the words "400 yards test swim in the sea on a course from the jetty to 200 yards north of the jetty; the swim to be carried out both with and against the tide or current" and inserting "400 metres test swim in the Henley Baths."

- (d) Clause 4c amended by deleting the words "100 yards" and inserting "100 metres."
- (c) Clause 4a of the Junior Section amended by deleting the words "Swim 100 yards in 140 seconds in the sea" and inserting "Swim 100 metres in 140 seconds in the Henley Baths."
- (f) Clause 14 amended by deleting the words "October" and inserting "August."

A. Hallett moved, and M. Butterfield seconded, that the retiring President, R. J. McDonough, Esq., be made a Life Member. This was agreed to unanimously.

SPECIAL GENERAL MEETING.

A Special General Meeting was convened and held in the Club Shed on Sunday, 10th April, and passed the following amendments:

- (a) Clause 14 amended by deleting the words "three-fifths" and inserting "more than half of previous season's Active, Active Reserve, Associate and Life Members to form a quorum."
- (b) Clause 16 amended by deleting the words "three-fifths" and inserting "more than half of previous season's Active, Active Reserve, Associate and Life Members to form a quorum."
- (c) Clause 20 amended by inserting after the words "Management Committee" as a separate paragraph the words "All officers of the Club, Associate Members and Life Members who are desirous of having a Club Blazer and have not passed the Reel and Line Examination, have the appropriate words embroidered in the centre of the Club Badge. This Badge will not have Laurels or Reel in the centre."
- (d) Inserting as Clause 20 (j) the words "Been selected as a member of a team to represent the State in Life Saving Competition."

CHELSEA VISIT.

It was our pleasure and honour to entertain the Chelsea (Victoria) Life Saving Club during its visit to Adelaide to take part in the South Australian Life Saving Championship Carnival at Port Elliot.

The team of 20 arrived some days prior to the Carnival, and we were happy to repay the hospitality afforded us last season by the West St. Kilda by making our Club Shed and equipment available for their training, and also supplying their transport and eats on the day of the Carnival.

A fine bunch of chaps, and we hope to see them again in the near future.

CLUB PICNIC.

The Club Picnic was held at Long Gully on Sunday, April 24th. Although attendance was disappointing, a good time was had by all, the weather being on the cool side. The majority of members spent their time beside the fire rings, when not playing tennis and football; cricket held attention for only a short period.

PRESENTATION NIGHT.

Owing to unforeseen circumstances, caused by power restrictions, the Presentation Night, which was to have been held on Saturday, 25th June, 1949, was cancelled, and it is to be held at a later date.
