## PRESIDENT'S REPORT

When consideration was being given to building the northern wing of the Club House, strong warnings were given of the financial burden that the Club would be placed under. Later, with the assistance of a grant from the Government, a substantial gift from our benefactor, Miss Amy Forwood, and a loan from the Henley & Grange Council, the Club benefitted by the erection of the new additions.

Plans to finance and repay the loan to the Council were promoted and accepted by the members. Schemes to raise funds to repay the loans were promulgated and in fact appeared to be working towards the final goal of satisfying our debts.

Then a change came over the scene. Prominent figures involved in management, senior swimming competitions, senior and junior water event coaches and regular attenders of the social club, drifted away from the Club and in some instances joined other Clubs to compete against our members. Subsequently our plans to free ourselves of the encumbrance of our debts fell in a heap.

The question should be asked: "Why this exodus of key personnel from the Club". One answer that I may make is the fact that there are quite apparently two divided sections of the Club. The boat crews and the rest of the Club. Too much emphasis has been placed in the 'Boaties' area to the detriment of others, with the consequence that well known swimming and craft competitors have left for other Clubs where there is an appreciation of talent and keen competition within those Clubs to get in the respective 'A' teams.

Don't get me wrong. I believe 'Boaties' are a fine bunch of fellows but they must be prepared to accept other sections of the Club. There has to be a continuing 100% effort by all members of the Club to raise funds for General Funds Account on a continuing basis so that the Management Committee may allot amounts from that fund to areas of need in the various sections of the Club where necessary, and not the various sections raising funds for any item that that particular section requires. By this method, the stronger sections of the Club, with the greater fund-raising capacities and potentials, will improve their lot considerably, whilst the other sections of the Club, without the numbers behind them find it practically impossible to get ahead. We must ALL pull together to strive for a common cause in rebuilding the Club. We have rebuilt the Club with mortar and bricks: now let us ALL endeavour to rebuild the Club in numbers, in competitive arenas and in assisting the Treasurer in keeping the Club on the rails. Let us all strive to make Henley the formidable competition Club of the past. It can be done if we ALL put our shoulders to the wheel.

Travel commitments I have entered into following my retirement after 37 years with the S.A. Police Department will prohibit my attendance at the A.G.M. or continuing in my present capacity as President.

I wish the Club all the best for the ensuing seasons.

To follow this, I must also congratulate these cadets for their dedication and effort in achieving such a position. Very well done, and maybe the other members can learn from your example and realise that with steady hard training and dedication, it is possible to be amongst the best in Australia when competing. Once again, congratulations and well done.

Unfortunately, no other area was able to achieve as high an award, although the Board and Ski members put in their best effort amidst the upheaval of losing some key members.

My thanks and appreciation go to those members of the various committees who continued to make time and gave their unfailing support throughout the season. Thanks must also go to my vice-captain, Jim Goldsmith, for his help and for carrying out his duties, thus making my job a little easier.

This year Henley was fortunate to be assigned one of the KESAB vehicles on loan to the Association. Generally, most members appreciated the relief it brought from the boredom of patrols by being conscientious when using the vehicle, but there were a few members who decided it was a fun machine and abused the privilege.

Before Henley can become a united force in the Association, it is only you, the members, who can do anything constructive to make the Club a more united Club. In doing so you, the members, will once again be proud to be associated with the Henley Surf Life Saving Club.

## SECRETARY'S REPORT

I am pleased to report on the Club's progress in our 61st year. There were many highlights during this season - nothing dramatic, but progress in most areas occurred, and if we keep trying, our Club will become even better.

Nine people gained their bronze medal (seven down on last year) and two cadets joined our ranks (6 less than last year). We must put more effort into increasing our membership as this shares the work load. It also increases attendances at our functions and assists in club spirit.

As you will see from our Honorary Treasurer's Report we spent more last year than we obtained, thus eating into our reserves. This must not happen next season. Our annual subscription must be considered at this Annual General Meeting and I think \$35.00 per senior member would seem to be a reasonable amount to enable you to patrol our beaches. Consider some of the costs: this report costs about \$3.00 per person to produce even though every cheap avenue is followed. Our registration and insurance fee for each member was \$9.00 last season and could increase again. The cost of awards and life saving manuals has increased along with the cost of competition (\$2.00 for each competitor at our carnivals, plus \$8.00 for State Titles and \$8.00 for the National Titles). Additionally, like every home, the cost of electricity and gas has increased, along with the cost of insuring our building and gear.

The attendance at committee meetings was reasonable for the year but often people left early and the attendance chart is not therefore a completely accurate record of involvement.

In the competition area our members' performances saw improvements in all areas except R. & R. and swimming. As this is a most important area, I hope we can attract more swimmers to join.

Several members attended a live-in Instructors Conference for which the Club was happy to pay the \$45.00 per head fee. One of our cadet sprinters was given assistance to enable him to gain valuable competition in Sydney last January and we thank the Glenelg Club for allowing him to travel with them and for looking after him.

It was pleasing to see Andrew Morrison arrange the donation of a single ski from The Meat Connection and last year's President, Bob McKenzie, donated another ski because of his promise to match our efforts up to two skis. The donation from Carlton United Brewery of \$8,000 towards the Fosters Lager Surf Boat was a tremendous boost to our Club and C.U.B. have assisted us in many other ways. I hope that members will support them and our other sponsors as listed in the Report. Remember without sponsorship our Club would not have the terrific quality of gear that is available for your lifesaving and fitness training.

Finally, I would urge members to consider standing for committee positions. Valuable experience and personal development can be gained from committee involvement. Lifesaving is becoming a serious business with Clubs having many legal responsibilities and increasing administrative tasks which members can apply themselves to. Please offer yourself for positions but be honestly prepared to carry them out to your best ability.

Mulvihill's car. We also held a surf boat knock out competition with \$300 prize money donated by the 150 Jubilee Board. Grange won \$200 and our Club won the \$100 second prize.

A special thanks must go to Tom Jennings and Chook Fielder for arranging an historical life saving display at the Henley Town Hall which, along with other local groups, was open during the "Back to Henley and Grange Week".

## BOAT CAPTAINS REPORT

The past season got underway about July with weights and running for those who were keen enough.

During Winter, sponsorship was gained for a new surf boat through Carlton United Breweries. A Blue Clymer fibre-glass foam sandwich boat was ordered which was to have Foster Lager sign-written on it. Henley Hotel donated a set of timber oars to go with the boat. A new boat trailer was built by myself and J. Goldsmith, D. Slaven, S. Jennings and myself travelled to Sydney with the trailer to pick up the new boat in late October.

This season saw the Club gain a coach from outside the Club in Steve Crouch who used his experience in river rowing to coach the crews early in the season.

With a 2nd in the As, a 1st in the Reserves and a 3rd in the C2 team at the first carnival, the Club was set to be competitive this season. The A and C2 crews competed at Warrnambool, Victoria, in February. The A crew reached the Four Boat Final both days. At the Goolwa carnival, the A crew won both the Open and West End boat races, making them the first crew to beat Grange in two seasons.

Various maintenance work was carried out on the equipment. The Ramsgate boat received a new coat of varnish on its interior. The Doherty's bow box was repaired twice during the season. And there were the usual weekly repairs.

The State Titles had mixed results. The As had the chance of taking out Gold but the surf got the better of the crew and they had to settle for a Bronze. The Bs rowed well and took out the Silver. Our C crew just missed out on a medal and the C2s missed out on making the final due to the heavy conditions.

4 crews represented the Club at the Australian Titles at Moana. The Friday saw our 3 reserve crews put out due to the keen competition. The Open boat crew rowed well to make the third round and missed the quarter finals by a place. Most of the members attended the boaties convention on the Monday which wound up the Season.

On completing my report I would like to thank all who helped in maintenance, towing and funding in the boat area. Also thanks to all who rowed during the Season.

In the Junior section, few craft paddlers chose to compete in ski events. Thus a great deal of work needs to be done to increase the depth of competitors in this and the open age group by fostering enthusiasm in the cadet section and junior division to provide a larger foundation of young members.

A number of female competitors showed interest in malibu paddling pre-season but only Carmel Lanyon attended training and carnivals, including a good placing in the surf at Goolwa.

In the senior section there were no regular competitors, with even the Board Captain being sidelined with injury.

## TREASURER'S REPORT

The following Statements and Balance Sheet have been prepared to provide the financial transactions for Season 1986/86.

More detail has been included in the Receipts and Payments, and Income and Expenditure Statements to enable members to have a clearer knowledge as to the financial running of the Club.

The season saw payments of \$55,800.00 compared to receipts of \$50,570.00, being over-expenditure of \$5,230.00. This necessitated the transfer of our \$8,000 invested in F.C.A. Ltd, to be placed in the General Account.

With our requirement to repay our current two building loans, the Club is in need for the forthcoming season to embark on an increase in fundraising activities to meet our loan repayments, operational and administrative overheads.

The Top Room Revenue includes bingo ticket sales and the income received from the sale of liquor at the two functions held during the year. Comparison with this years trading to past seasons shows a downturn in the bar trading. My appreciation is extended to Mark Searcy for his efforts in managing the Top Room, but the need exists for his efforts to be supported and a much greater controlled usage of this facility is required to justify its operation.

The Social Club through the efforts of Michelle Richardson and an extremely small band of helpers contributed \$1,500.00 to the General Operation of the Club through the running of two shows and the after-Carnival barbecues.

The acknowledgement to our donors and sponsors listed in the Annual Report is greatly appreciated for without such support the Club would not be able to operate and perform at its current level.

The audit of the accounts for the Club was completed singularly by Mr. Geoff Duhne as Mr. Peter Peppin was unavailable for the audit.

I trust that the advice as to current financial status of the Club will encourage every member to assist and work towards a much healthier position during Season 1986/76.
