## PRESIDENT REPORT: Jim Plouffe

Last year I outlined the main goals of the club as we underwent the difficult task of rebuilding after the collapse of our commercial kitchen. The main goals, in order, were to straighten out our finances, plan to increase membership and rebuild the culture of the club. Each week I updated members through the newsletter about our progress and plans.

As a community club run by volunteers, I was well aware of not burning anyone out while herding all our ducks into a row. I am not sure I succeeded in this, in that this past year was difficult for a core group of people as we dealt with all the challenges. To all who put up a hand and helped, I thank you - especially our Vice President Lennie Hitch, who quietly goes about getting essential stuff done.

On the financial side, under the stewardship of Adrian Marshall we have taken the club from \$100s of thousands in debt to a point where we can essentially declare we have a clean ledger and system to pay our ongoing, legacy debts. I cannot thank club members enough for their understanding and help in getting us here. There has been uncountable behind-the-scenes hours of negotiations and financial wrangling to get to this point.

Our financial position would have been stronger at the end of the season, but the lease took longer to negotiate to ensure we got the most benefit out of the necessary change and we finally had the balcony fixed - which cost the club and Ocean lost patronage.

We had a strong season of sponsorship from other partners, with Michel Boutin and I bringing in new partners. I won't name them all here but thank all of our supporters for their generous donations. Without these partners we would not have made it through the season, so when you see them listed in the weekly newsletter, please support them in kind.

This coming season we have a goal of creating a system that makes it easier to pay your membership - our national legacy systems are confusing and make it very difficult to ensure every member pays the right amount. This will again help our bottom line.

It was heartening to see that our actual membership numbers increased last year despite the fact that we did not have a formal membership strategy in place. This season Dan Moriarty has begun what I see as a three-year process to rebuild membership and the sporting aspect of our club. Saying that, our patrolling membership is still the envy of the coast, and I thank

all patrolling members for the many hours put into training, maintenance and patrolling - both at the club, at our sister club Chiton and on state patrols.

Lastly, culture.

I bit off more than I could chew last year, thinking we could smash out the lease before the season started, giving us time to concentrate on membership before Christmas and then move to culture during the heat of the summer. This didn't happen, with finances taking all the way to now and settling our Ocean partners in to the club still ongoing.

I would be lying to say I wasn't a bit disappointed that all club members couldn't recognise the extreme stress the Board of Management and Commercial Group was under, but I once again thank members for their patience. If we all pull together in the same direction, surfing the challenges we face will be much easier.

I was away during the club presentation night so didn't have the chance to publicly thank people for their efforts - I want to formally thank Roy Menner for the months he put into cleaning up the club, stocktaking and generally keeping the place secure the dark winter of 2023 as we planned and negotiated what to do with the club.

Highlights of the year include our Nippers and Youth teams competing well above all expectations both on the beach and at pool rescue - with our largest contingent of state reps in the pool the club has ever produced. Our Masters continue to impress and there are plans a foot to rebuild this group this year, under the guidance of Sports Captain Neil Wackener. As I said before, our patrolling is envied up and down the coast thanks to the hard work our Club Captain Bec Forest and her team put in all year round. This is what we as an emergency service are here to do and this will only become more and more important as Henley Beach stamps itself as the place to be in SA.

Lastly, the biggest change was welcoming Ocean Bar & Kitchen in as our commercial partners, a huge change to get used to and one that will continue to evolve as the years progress and we work together to make Henley Surf Life Saving Club the place to be. I ask all club members to support Ocean - the food is delicious, the 10% discount more than generous and the drinks the cheapest on the Square.

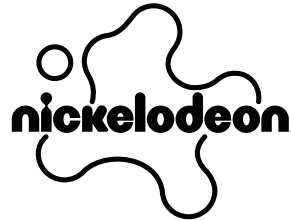

## FINANCE MANAGER REPORT: Adrian Marshall

The purpose of the Finance Manager's report is to provide some context and commentary to the financial statements that are enclosed in this report as provided by the Club's appointed accountants, Perks Accountants and Wealth Advisors. This report covers the July 2023 to June 2024 financial period.

### Financial Position at the Start of the Period

At the start of July 2023, the Club had just posted a loss of \$245,940 with total liabilities of \$322,559 for the 2023 financial year. The loss and much of the debt occurred in the operation of the Club's bar and restaurant. The Club's debts consisted of liabilities for hospitality goods and services \$42,777, the ATO for GST; \$104,456 and the loan from the Kanini Foundation for the Club building, built back in 2013; \$163,888. A positive to take away from this period was that the Club was able to stand down the hospitality staff during the year and pay out their rightful entitlements.

The factors that saved the Club from insolvency in 2023 were:

- A loan from Surf Life Saving South Australia of \$50,000 with flexible repayment terms that enabled the Club to pay the debts to the hospitality goods and services suppliers,
- A structured payment plan to pay the ATO monthly until June 2025 to repay the GST debt,
- The gracious Kanini Foundation who agreed for the annual distribution to the Club be allocated to service the loan interest payments, and

- A robust business plan that included:
  1. Leasing the bar and restaurant to an established hospitality group,
  2. Raising funds for the Club’s core lifesaving, safety awareness and sporting activities and
  3. Eliminating all unnecessary Club expenses.

### Current Financial Position

12 months later, at the end of the June 2024 financial period and only after huge efforts of Club members during the year, the Club has made significant progress on the road to financial sustainability.

The 2024 financial statements show the Club’s bottom line was a loss of \$99,174. However, if we were to exclude depreciation, amortisation and interest expenses of \$147,656, the Club made a modest profit of \$48,482 whilst reducing its debt to the ATO and providing services to members and the Henley Beach community. It is this modest margin and the commitment of Club member’s to fundraising that demonstrates the Club has the capacity to prosper once it has finalised its repayments to the ATO and Surf Life Saving SA. The Club will pay its final payment to the ATO in June 2025 and finalise its repayments to Surf Life Saving SA in July 2027.

### Revenue

In July 2023, the Board of Management (BoM) and a dedicated group of volunteer Club members set their minds to deliver a series of ambitious revenue targets set in the Club’s 2024 financial year business plan. Whilst some of the targets were not met in full, it is these actions of Club members to achieve these targets that has Club on a path to financial sustainability. Club revenue consists of membership fees and fundraising which include grants, sponsorships, the barbeque and donations. The new revenue stream of the restaurant sub-lease and the day-hire of the member’s Top Room came online in January 2024 with steady income received from that time.

### Commercial Group

A big thank you must go to Grantley White, Brad Gauvin, and Margaret Menner who assisted the BoM in a commercial group who ran an EOI process through July to November of 2023 to sub-let the Club’s bar and restaurant. There were several additional contributors at this

time who stepped into provide valuable advice and technical expertise free of charge including Norm Collins from West Beach SLSC and Damien Foulis from HWL Ebsworth Lawyers. After an impressive refit, it was quite an achievement when Ocean Bar and Kitchen opened the week before Christmas 2023. An honourable mention must also be made to Jane Bray who helped the Club sell redundant furniture and equipment from the restaurant during this time.

### **Barefoot Bar**

After the restaurant was closed and in the absence of paid hospitality staff, a large group of volunteers came together led by Lenny Hitch and Roy Menner to run the bar and restaurant with the remaining stock on hand. These evenings were well supported by the Club membership with many families attending. The Fleetwood Mac tribute night will go down in history as one of the great nights at the Club, all thanks to the Club's volunteer members. At the end of the period the Barefoot Bar has contributed a surplus of \$21,446 to the Club. Whilst not as high as initially expected, it is a significant portion of club revenue and represents a significant contribution of members time and efforts in support of the Club.

### **Grants Program**

The Club's grant program is vitally important for the purchase of new equipment for lifesaving, the Nippers program and other community programs delivered by the Club for the community. In this area, David Cassidy has done a fantastic job handling all aspects of grant writing, correspondence and acquittal of grants received, raising an impressive \$45,168 for the Club. This work has enabled the purchase of new rescue boards, life jackets for the IRB, roof racks for the ATV, first aid training equipment, benches for the change rooms, a new TV in the Club's Top Room, and shade tent for the BBQ, and a new board and ski trailer. David, the Club thanks you for this outstanding contribution!

### **Business Partnerships**

In the area of Club sponsorships, Club President Jim Plouffe and Michel Boutin did some excellent work securing multi-year business partnerships early in the 2024 financial year with Nickelodeon and YO CHi and many other single year agreements. All in all the Club received \$31,362 through these vital business to business relationships, including Barossa Fine Foods, Henley Square Foodland, Seaton Swim Centre, Rip Curl Henley Beach, SOS Safety Signs, JCA Life Consultants, Horsman's Plumbing and Gas, Perks Accountants and Wealth Advisors, Ocean Bar and Kitchen, Blue Lake Refrigerated Transport, and Prospect Motor Co and Bendigo Bank. These partnerships have resulted in new shade tents and flags for the beach, new uniforms and apparel and a generous supply of the best sausages in Australia for the Club's fundraising BBQ.

## Fundraising

Yet another significant contribution of Club members was the fundraising activities including the BBQ, donations and the sale of raffle tickets. This area contributed an outstanding \$14,075 to the Club. The role of the BBQ to bring members together and connect with the community whilst raising funds for the Club's surf lifesaving activities cannot be understated. It is also very humbling to see Club members take advantage of the Club's charity status and make tax deductible donations to the Club this year, with donations increasing four-fold this year to \$4,119. Going forward it is the intention of the current BoM to see the Club establish a sinking fund, so that donations can be cautiously invested to grow and provide capital for the Club's future building projects.

## Expenses

On the expenses side, importantly the Club reduced its overall expenses by 26.5% or \$57,778 in the 2024 period compared with the previous year. The enormous contribution of Paul Maidment and Lennie Hitch to our building maintenance and management has been instrumental to this. This efficiency isn't entirely positive with some important maintenance and utilities expenses being deferred to the 2025 period. In a positive sign for the Club, competition expenses increased 12% or \$1,526. A big thankyou must be called out to our maintenance team lead by Paul Maidment and Lennie Hitch, who have engaged maintenance contractors on an 'only if essential' expenditure budget.

## Summary

Notwithstanding the loss for the year and net current liability position at 30 June 2024, the board of management is of the opinion that the Club can continue to operate as a going concern after giving due consideration to the loans from Surf Life Saving SA, Kanini Foundation and the repayment terms to the ATO and the Club's lease agreement with Ocean Bar and Kitchen combined with the generous support from members, funders, and sponsors to cover the operating expenditure the Club requires to provide its services to Club members and the community.

The positives from the 2024 financial year were that the Club membership banded together and saved the Club from a financial disaster. In sub-leasing the Club restaurant and bar, our Club members can leave the hospitality to the experts at our stunning beach location whilst reaping the benefit of a vibrant Club environment with a steady income and reduced building expenses to base our Club activities. The Club also ensured the 'Top Room' was kept for members to hold meetings, training and socialising, whilst also creating another potential revenue stream via meeting room hire for corporate events, catered by Ocean Bar and Kitchen. The Club has reduced its debt to the ATO with regular payment, which conclude in June 2025. Before depreciation, amortisation and interest, the Club made a conservative profit in 2024. In closing I would like to thank the Club Board and members

their support of me in the role of Club Finance Manager during this term, I wish the Club and its members a long, safe and sustainable future!

## VICE PRESIDENT REPORT: Lennie Hitch

As the Vice President of Henley Beach Surf Life Saving Club, I am pleased to present the annual report for the season 2023 - 2024. In this report, I will provide an overview of the club's maintenance activities, challenges, and future plans. It is important to acknowledge the challenges faced and communicate transparently about the club's performance.

### Maintenance

Current Status Facility Condition:

The club's facilities are currently in good condition. Regular inspections have been conducted to ensure safety and functionality.

Repaint of Club:

At the end of our lease every 10 years, the exterior of the club needs to be repainted, this is forecast for the 2024-2025 season.



### Recent Work:

Over the past year, we have completed several key maintenance tasks, including:

Clubhouse Repairs: Balcony repairs have commenced and are forecasted to be completed by mid-August.

Equipment Servicing: Regular servicing of lift, fire alarm system and fire doors.

New Craft Trailer: Replacement of board trailer, with new multi-use craft trailer for boards and skis.

Club Air Conditioning System:

Is nearing end of life, this has been identified to the council and have asked for them to prepare replacement cost in their upcoming budget.

Club Ramp:

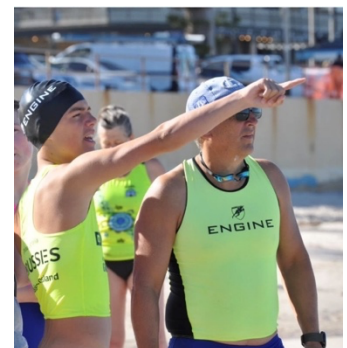
Has also been identified as needing replacement in the next 2-5 years, council have been advised, and a budget will need to be submitted.

### Challenges

Budget Constraints:

Balancing the budget for necessary repairs while planning for long-term improvements. i.e. Off-site storage:

We have a committee working on offsite storage who have now identified and leased a site from the West Beach Trust. Raising funds for a significant asset as a shed, is going to be a significant challenge.

## Overview of the patrol season.

The patrolling season commenced on Saturday 7th October 2023 and ended on Easter Monday 1st April 2024. The season was a very busy one for Henley patrolling members, with many beachgoers visiting Henley to enjoy the Square, and extended patrol hours throughout the months of December and January. Our patrol teams all displayed exceptional professionalism and performed their duties to a very high standard.

We had 10 patrol groups this season as well as special patrols for Nippers Water Cover, Jetty to Jetty Swim, Henley Masters swim, Extreme Hot weather policy days and public holidays.



I would like to thank every member who patrolled and a special thanks to our Patrol Captains who worked so hard to ensure we delivered our services to the highest possible standard. At the beginning of the 2023-2024 season, we welcomed several new patrol captains and Vice Captains. Thank you to these dedicated members for stepping up to such an important role and demonstrating strong decision making, communication and leadership skills. Together with their vice-captains, Henley's patrol captains effectively coordinated and guided their patrol groups (of between 14 and 22 members) to fulfill the requirements of the club's patrol agreement with Surf Life Saving South Australia (SLSSA). We patrolled a total of 4746 hours at Henley during the 2023/23 season. Eight members completed greater than 50 hours on patrol and 46 completed more than 30 hours. These figures represent significant contributions, and we are very grateful for the individual efforts. The majority of patrols successfully used the IPAD to log in to surf house this season to log everything in electronically. As well as the rostered patrols, many members volunteered

extra time to provide water cover at events such as extra weekly junior trainings both at Henley and West Lakes, end of school break ups, ANZAC day ceremony and open water swims. It is a great reflection on the Club to be getting involved in so many community events Team Henley pulled together to ensure the safety of participants. These events showcase the important skills and community involvement of surf lifesavers and play a critical role in raising the profile of our club. Our patrols were kept very busy over the season with multiple shark alarms, inclement weather, EPA warnings and participated significantly in a major rescue off the end of the jetty. Congratulations to all members involved for their excellent use of lifesaving skills. One of the highlights has been to see our young members development and evolution from juniors to the exciting world of gaining their surf Rescue Certificates (SRC) and joining Henley Youth Team (HYT). While some of the teens are motivated by competition, others prefer to hang out with friends at the club and others shine as patrol members.

### Patrol Information and Statistics.

Between October 2023 and April 2024, Henley volunteers made it possible to carry out almost 90 patrols. This included Christmas Day, extreme hot weather patrols, water cover for jetty to jetty swims, Easter holidays and radio cover at surfcom. Bronze medallion holders also provided water cover for junior activities.

In addition to patrolling, many of our members volunteer for other club initiatives. Big thanks to Sue Mitchell and Sam Menner for coordinating Surf Babies, Wiltja programs and Snippers.

## POOL RESCUE SEASON 2024: Nigel Tunbridge

Pool Rescue is another area of surf lifesaving that uses competition to test and ensure our lifesaving skills are rescue ready. Season 2024 commenced following the completion of the Surf Season with Sunday morning training sessions at SA Aquatic Centre seeing an excellent turnout each week and loads of enthusiasm.

Over the course of the season, 24 Henley SLSC members wore the Henley cap with pride, with many of those having their first foray into Pool Rescue competition.

The Henley Pool Rescue team ran a club BBQ fundraiser and organised a training camp at Chiton Rocks / Fleurieu Aquatic Centre which was a lot of fun. The approach to training and practice and 'having-a-go' played a significant part in the club's result this season - giving our team an edge over much of the competition.

The first inter-club carnival of the season was held 24 May followed by carnivals on 14 June and 21 June. These carnivals were a great way to experience and hone specific techniques under a competition setting ahead of the State Championships.

Henley SLSC finished 4th at the 2024 SA State Pool Rescue Championships!

SA Pool Rescue State Championships were held over 3 sessions across 3 days from 5-7 July with Henley SLSC represented by 18 members comprised of: 2 x Nippers, 9 x Youth, and 7 x Masters, with the squad accounting for 62 entries across the championship events (excluding entries into composite teams). We were without U11 Louisa Simpson-Purkiss as she was representing the state in Water Polo in Tasmania, and U14 Raf Fiorinotto who had competed in all the carnivals leading up to States but was ultimately ineligible for the carnival. We're sure to see those girls back on the pool deck next season.

The Friday evening session of the State Champs opened the carnival with the Line Throw and Obstacle events, and immediately Henley was on the board with Xavier Tunbridge and Logan Ringwood taking out gold in the U14 boys 10m Line Throw. More medals followed including club president Jim Plouffe taking gold in the Masters 50-59 100m Obstacles, and our U14/15 girls of Emma Christensen, Millie Shatwell, Abbi Davidson and Georgia Maidment taking silver in the 4 x 50m Obstacle relay.

The Friday evening session gave us the privilege of seeing Seacliff's Taj Ward and Fletcher Luscombe smash the Open Men's Line Throw world record in a time of 8.69 seconds which lifted the roof off the SA Aquatic Centre and left a sense of excitement in the air for the remainder of the championships.



The second session on the Saturday afternoon comprised the tow and carry events - these events simulate the rescue and return to safety of patients, under timed race conditions. Again, Henley was on the board early with Abbi Davidson holding off some strong competition to take bronze in the U14 girls 100m Manikin Tow, Xavier Tunbridge taking gold in the boys event, and Alex Laws taking gold for the Women's masters while setting a new state record. Again, the medals kept coming including Emma Christensen and Karim Nasr each taking silver in the 200m Super Lifesaver for their age groups and Alex taking another gold in the Masters women 100m Manikin Carry in another State record time.

The final day saw the team relays, the individual rescue medley and 50m with fins events. Again, the Henley team stayed focused and the results flowed. Alex Laws set another state record on the way to gold in the 50m with fins, Jim Pouffe also taking gold in the same event, and gold for Emma Christensen and Karim Nasr in the 100m rescue medley.

Our amazing result was 4th overall with 127 points, finishing ahead of traditionally competitive clubs such as Grange, Brighton and Glenelg, and was the best result for Henley for some time. Importantly, the result was impossible without our team of officials, timekeepers, handlers etc. It was a wonderful team effort - and a special mention to our Nippers, Madison Mews and Hamish Tunbridge who truly embodied the Henley FIRST values as they did their best all season, took a wealth of experience for the seasons to come, helped out on the pool deck, and also selflessly combined with other clubs to form teams to ensure as many people got to experience the competition as possible. Well done to everybody.

# Notes to the Financial Statements

For the Year Ended 30 June 2024

The financial report covers Henley Surf Life Saving Club Inc ("the Club") as an individual entity. Henley Surf Life Saving Club Inc is a not-for-profit Association incorporated in South Australia under the *Associations Incorporation Act 1985* ("the Act").

The financial statements were authorised for issue on the      day of August 2024.

### 1 Summary of Material Accounting Policy Information

The board of management have prepared the financial statements on the basis that the Club is a non-reporting entity because there are no users dependent on general purpose financial statements. These financial statements are therefore special purpose financial statements that have been prepared in order to meet the requirements of the *Australian Charities and Not-for-profits Commission Act 2012* ("ACNC Act"). The Club is a not-for-profit entity for financial reporting purposes under Australian Accounting Standards.

The financial statements have been prepared in accordance with the mandatory Australian Accounting Standards applicable to entities reporting under the ACNC Act and the material accounting policy information disclosed below, which the board of management have determined are appropriate to meet the needs of members. Such accounting policies are consistent with those of previous periods unless stated otherwise.

#### Statement of Compliance

The financial report has been prepared in accordance with the Act and following the material accounting policy information outlined which are consistent with the previous period unless stated otherwise.

The financial statements have been prepared in accordance with the mandatory Australian Accounting Standards applicable to entities reporting under the ACNC Act and the Act, the basis of accounting specified by all Australian Accounting Standards and Interpretations, and the disclosure requirements of Accounting Standards AASB 101 *Presentation of Financial Statements*, AASB 107 *Cash Flow Statements*, AASB 108 *Accounting Policies, Changes in Accounting Estimates and Errors*, AASB 1031 *Materiality* and AASB 1054 *Australian Additional Disclosures*. The Club has not complied in full with AASB 16 *Leases* in respect of the lease of the Club's premises and AASB 15 *Revenue from contracts with customers* in respect of membership fees that are recognised when invoiced and not over the membership period.

#### Basis of Preparation

The financial statements, except for the cash flow information, have been prepared on an accrual basis and are based on historical costs unless otherwise stated in the notes. Material accounting policy information adopted in the preparation of these financial statements are presented below and have been consistently applied unless stated otherwise. The amounts presented in the financial statements have been rounded to the nearest dollar.

**(a) Going concern**

The financial report has been prepared on a going concern basis, which contemplates continuity of normal business activities and realisation of assets and settlement of liabilities in the ordinary course of business.

The Club incurred a loss for the financial year ended 30 June 2024 of \$99,174 (2023: \$245,940) and has a net current liability position as at that date of \$28,473 (2023: \$80,447), which indicates a material uncertainty in relation to the ability of the Club to continue as a going concern.

Notwithstanding the loss for the year and net current liability position at 30 June 2024, the board of management is of the opinion that the Club can continue to operate as a going concern after giving due consideration to the following:

- 1) On 31 July 2023 the Club entered into a loan agreement with Surf Life Saving South Australia Inc for \$50,000 to assist in the payment of existing creditors. The loan is subject to interest at the cash rate plus 1%, with interest payments commencing quarterly from 31 December 2023 and quarterly principal repayments from 1 July 2024. On 19 August 2024, the Club entered into a variation to the original loan agreement to defer the commencement of the quarterly repayments to 1 July 2025 with a final repayment date 30 July 2027.
- 2) On 7 July 2023 the Club entered into a 2-year payment arrangement with the Australian Taxation Office ("ATO") for outstanding liabilities totaling \$104,411 as at 30 June 2023. The outstanding balance with the ATO at 30 June 2024 is \$48,085, which is expected to be repaid by 30 June 2025;
- 3) On 4 January 2024 the Club entered into a lease agreement with Ocean Trading Unit Trust, sub-leasing the kitchen / restaurant facilities; and
- 4) The Club can maintain sufficient support from members, funders, and sponsors to cover the operating expenditure of the Club.

Given the board of management's opinion that the Club will be able to continue as a going concern, assets and liabilities have been recognised on the basis that the Club will be able to realise its assets and liabilities in the normal course of business.

**(b) Revenue**

**Trading income**

Revenue from the sale of goods or services are recognised upon delivery of goods or services to the customer.

**Membership fees**

Membership fees are recognised at the point in time the membership commences or is renewed by an existing member.

Grant income is recognised in the period in which the grant relates, in line with performance obligations of the grant.

**Fundraising and other income**

Fundraising and other income is recognised as revenue when received.

**Interest Revenue**

Interest is recognised using the effective interest method.

All revenue is stated net of the amount of goods and services tax (GST).

**(c) Income tax**

The Club is exempt from income tax under Division 50 of the *Income Tax Assessment Act 1997*.

**(d) Goods and services tax (GST)**

Revenue, expenses and assets are recognised net of the amount of goods and services tax (GST), except where the amount of GST incurred is not recoverable from the Australian Taxation Office (ATO).

Receivables and payable are stated inclusive of GST.

Cash flows in the statement of cash flows are included on a gross basis and the GST component of cash flows arising from investing and financing activities which is recoverable from, or payable to, the taxation authority is classified as operating cash flows.

**(e) Property, plant and equipment**

Property, plant and equipment are carried at cost and are depreciated over their useful lives to the Club.

**Depreciation**

Property, plant and equipment depreciated over the asset's useful life to the Club, commencing when the asset is ready for use.

Leasehold improvements represent the total construction cost of the Club's premises and includes amounts contributed by the Minister for Emergency Services and the City of Charles Sturt as part of the redevelopment. The building is on Crown land and is leased to the Club from the City of Charles Sturt. The lease is for 10 years with an option to extend for a further 10 years, having commenced in 2013. The board of management will be renewing the lease for the further 10 years.

The leasehold improvements had previously been depreciated at a diminishing value rate of 1.75%, with no depreciation recorded prior to the 2021 financial year. An adjustment was made to opening retained earnings in the 2023 financial year to recognise accumulated depreciation from the commencement of the leasehold improvements useful life, at a straight line rate of 2.5% i.e. 40 years useful life. This resulted in an additional \$567,772 of accumulated depreciation being recognised to 30 June 2022.

The useful life of the leasehold improvements has been estimated at 40 years, and not at the 20 years per the lease term. The board of management are of the opinion that given the specific nature of the leasehold improvements, that the lease with the City of Charles Sturt will be renewed in time, covering the life of the assets. If this situation should change in future financial years, the carrying value of the leasehold improvements will be adjusted accordingly.

## **2 Critical Accounting Estimates and Judgments**

The board of management make estimates and judgements during the preparation of these financial statements regarding assumptions about current and future events affecting transactions and balances.

These estimates and judgements are based on the best information available at the time of preparing the financial statements, however as additional information is known then the actual results may differ from the estimates.

The significant estimates and judgements made have been described below.

**Key estimates - impairment of property, plant and equipment**

The Club assesses impairment at the end of each reporting period by evaluating conditions specific to the Club that may be indicative of impairment triggers. Recoverable amounts of relevant assets are reassessed using value-in-use calculations which incorporate various key assumptions.




